## 1. Booking and Payment

The client's family and friends will be able to photograph the wedding as long as it does not interfere with the photographer's work. My break will take place during dinner time, when I will dine with the staff. Please note that my meal should only be taken into account for June 6, 2026.

## 3. Delivery

The online gallery will be delivery till 4 months after the day. The gallery will include around 800 photos. In the case of delivery with a box or album, it can be received at my office or with the option of sending to your address with extra shipping. If you lose or damage the photographs, these will be kept on file for up to 1 year from the date of the wedding.

## 4. Cancellation or Postponement
