Terms and Conditions

1. Booking and Payment

The Photographer Mariana Castanheira commits to make the photographic coverage service wedding professional of **Natalie Charalambous & Pedro Miguel Rito de Faria at Camélia Gardens in Sintra on May 30, 2026**. In order for the service to be booked, this document will have to be signed and delivered together with proof of payment of the first payment (40%) to the following email: geral@marianacastanheira.pt

The second payment (40%), will have to be made one month before the wedding till 30th of April 2026. The final payment (40%), will have to be made upon delivery of the photographs. In case of any extras after the contract signed (albums, additional hours, sessions, prints ...) these will be charged together with the final payment. The values of the presented albums are valid until 6 months after the date.

2. Exclusivity

Mariana Castanheira will be the exclusive photographer chosen by the client for the purpose of photographing the wedding. The client's family and friends will be able to photograph the wedding as long as it does not interfere with the photographer's work. I start working 2 hours before the ceremony on preparation. My schedule break will be on dinner time when I have dinner too with the staff.

3. Delivery

The online gallery will be delivery till 5 months after the day. The number of photos on the gallery it will be around 800 photos. In the case of delivery with a box or album, will be send to your address with extra shipping. If you lose or damage the photographs, these will be kept on file for up to 1 year from the date of the wedding.

4. Cancellation or Postponement

If the event is canceled by the client, Mariana Castanheira reserves the right not to refund the payment made till the moment. No amount invested will be refunded.

If the customer postpones it once due to some justified eventuality, for example in case it is not possible to perform weddings in the case of force majeure, such as death or illness, the client does not have any extra costs associated with it. The Photographer will do everything to manage to guarantee a new date for you.

If the Photographer is unable to enter into this agreement due to any eventuality, it assumes all the responsibility and costs that the client has had so far.

4. Copyright



6. Authorization to use images


The photographs will not be used for editorial or commercial purposes, they will only be used to publicize the work of the Photographer. If you do not agree, please contact.
